



## Privacy Policy

InterGlobe Enterprises has created the following privacy statement in order to demonstrate its policy on privacy, and also to endeavor full compliance with the extant Indian data privacy laws, including without limitation, the Information Technology Act, 2000 and the Information Technology (Reasonable Security and Procedures and Sensitive Personal Data or Information) Rules, 2011 which govern its collection and/or disclosure of the personal information and/ or sensitive personal data or information submitted by its users/customers, if any.

Please note that we do not offer any product or services under this platform outside India.

The following discloses our information gathering and dissemination practices for the Website. This website may contain links to other sites. InterGlobe Enterprises is not responsible for the privacy practices or the content of such other websites.

We use your IP address to help diagnose problems with our server and/or to administer our website. This gives us an idea of which parts of our site users are visiting. We do not link IP addresses to anything personally identifiable. This means that a user's session will be tracked, but the user will be anonymous. You can visit most pages on our site without giving us any information about yourself. However, our website may on various occasions require you to give us contact information like your name and email address and other personal information.

The nature of personal information or data usually received by us, includes:

- information about your personal details, viz., name, address, telephone/mobile number, e-mail, etc.;
- information which you voluntarily disclose to us by e-mail or other means, whether pursuant to a contract or otherwise, including through the 'Contact Us link' on our website;
- certain types of information are automatically received and stored whenever you network with us, e.g., through "cookies", called "pixel tags", "web beacons", "clear GIFs" or similar means, as discussed in detail below; and/ or
- all such information that is made available to us by your browser when you visit our website, viz., date and time of the enquiries put forth by you, your browser language, etc.

This privacy statement does not apply to any non-personal information disclosed by you or collected by us or any personal information or data which is in the public domain or which is disclosed under law.

We use your contact information only to respond to your queries or send you information about our company and/or any offers or promotions InterGlobe Enterprises and/or its partners may be offering. Users may opt out of receiving future mailings by choosing to request the same to us by return mail. We may use your personal information to make this website more relevant to your needs and create and publish content that may be useful to you. We do not retain any personal information or data received by us longer than it is necessary for achieving the corresponding purpose unless otherwise required under any applicable laws. We occasionally engage other parties to provide limited services to us or on our behalf. To the extent permitted by law, we will only provide those other parties the information they need to deliver the service, and they are prohibited from using that information for any other purpose.

InterGlobe Enterprises may disclose your personal information if required to do so by law, or if required to be disclosed to any Government agencies who are mandated under law to obtain such information for the purpose of verification of identity, or for prevention, detection, investigation including cyber incidents, prosecution, and punishment of offences, or in the good-faith belief that such action is necessary to:

- conform to the edicts of the law or comply with legal process served on InterGlobe Enterprises or the site;
- protect and defend the rights or property of InterGlobe Enterprises and its family of websites; or
- act in urgent circumstances to protect the personal safety of InterGlobe Enterprises employees, users of InterGlobe Enterprises' products or services, or members of the public.

To the extent required by applicable laws, your consent will be obtained prior to disclosure of any sensitive personal data or information collected from you, which consent is given by you expressly, including in terms of your use of our website.

InterGlobe Enterprises may use your information for internal business purposes, such as analyzing and managing its businesses. In the event that another company acquires all or substantially all of the assets of InterGlobe Enterprises' business through a consolidation, merger, asset purchase or other transaction, we, upon taking consent from you, will have the right to transfer all data (including any sensitive personal information or data) that is in our possession or under our control to such acquiring party and thereafter, the privacy policy of such acquiring party shall govern all such data and any personal information or data that is transferred to the acquiring party.

Web beacons, also known as clear gif technology or action tags, may be used to assist in delivering the cookie on our site. This technology tells us how many visitors clicked on key elements (such as links or graphics) on a web page. We do not use this technology to access your personal information, it is a tool we use to compile aggregated statistics about our website usage. We may share aggregated site statistics with partner companies but do not allow other companies to place clear gifs on our sites.

This website uses technology from its partners for the purpose of collecting and storing these cookies, for marketing and optimization purposes. These cookies do not contain any personal or private details (such as preferences, payment details, contact details etc.) and are virus-free. The use of the cookies also targets to deliver advertisements pertaining to your choice and interests and may also be placed on other websites by our advertising network partners.
